

Handshake x Gemini Summer 2026 Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

Eligibility:

This Sweepstakes is open to individual legal residents of the 50 United States, the District of Columbia ("Sweepstakes Territory") who are at least 18 years of age as of the date of entry. VOID OUTSIDE OF THE SWEEPSTAKES TERRITORY AND WHERE PROHIBITED OR RESTRICTED BY LAW. YOU WILL NOT BE ENTERED IF (1) YOU DO NOT MEET ALL OF THE ELIGIBILITY REQUIREMENTS OR (2) YOU FAIL TO COMPLETE ANY REQUIREMENT SPECIFIED IN THE "HOW TO ENTER" SECTION OF THESE OFFICIAL RULES. Each winner will be notified at the email address associated with the winner's entry. Handshake reserves the right to cancel the Sweepstakes at any time.
